## **2. Introduction**

At Bekho Team, we respect your privacy and are committed to protecting your personal data. This Privacy Policy explains how we collect, use, and protect your information when you use our HTML5 games.

## **3. Information We Collect**

### **3.1 Personal Data**

Our HTML5 games are designed to be completely self-contained and do not collect, store, or process personal data from users. We do not request or collect:

- Names
- Email addresses
- Physical addresses
- Phone numbers
- Payment information
- Any other personally identifiable information

### **3.2 Game Data**

Our single-player games store locally on your device:

- High scores
- Current level or game progress
- Basic game settings

This data is stored only on your device through cookies and is not transmitted to our servers or third parties.

### **3.3 Technical Data**

Our games may temporarily access basic technical information from your browser necessary for operation, such as:

- Browser type
- Screen resolution
- Rendering capabilities

This information is used only during the game session and is not stored or transmitted.

## 4. Use of Cookies and Similar Technologies

### 4.1 Game Cookies

Our HTML5 games use cookies and browser local storage (localStorage) exclusively to:

- Save high scores
- Maintain game progress (current level)
- Remember basic game settings

### 4.2 Cookie Characteristics

- **Purpose:** Exclusively to enhance the gaming experience
- **Duration:** Persistent (maintained until you delete them)
- **Scope:** Only stored locally on your device
- **Access:** Not transmitted to external servers
- **Content:** Only game-related data, no personal information

### 4.3 Cookie Control

You can:

- Delete cookies through your browser settings
- Disable cookies, although this may affect game functionality (you will lose saved progress)
- Consult your browser's help section for specific instructions on cookie management

## 5. Data Retention

Game data (high scores, progress) is stored indefinitely on your local device until you decide to delete it through:

- Browser settings (deleting cookies and site data)
- Browser cleaning tools
- Browser reinstallation

## **6. Third-Party Platforms**

Our games may be distributed through third-party platforms. These platforms may have their own privacy policies and data collection practices. We recommend reviewing these platforms' privacy policies before using our games through their services.

## **7. Sharing Information with Third Parties**

Since we do not collect personally identifiable data, we do not share, sell, or transfer personal information to third parties. Game data (scores, progress) is stored only on your local device and is not transmitted to our servers or third parties.

## **8. Information Security**

Although we do not collect personal data, we implement appropriate security measures in the development of our games to protect against unauthorized access, alteration, disclosure, or destruction of information.

## **9. User Rights**

### **For Users in Chile**

In accordance with Law No. 19,628 on Protection of Private Life of Chile, users have rights regarding their personal data. However, since we do not collect personal data, these rights are not applicable to our games.

### **For Users in the European Union (GDPR)**

Although we do not collect personal data, we recognize the rights established in the European Union's General Data Protection Regulation (GDPR).

### **For Users in California (CCPA)**

We comply with the California Consumer Privacy Act. Since we do not sell or share personal data, it is not necessary to provide a "Do not sell my personal information" link.

## **10. Games for Minors**

Our games are designed to be safe for users of all ages. Since we do not collect personal data, we automatically comply with regulations such as COPPA (Children's Online Privacy Protection Act) in the United States.
